

## Arbitration Award Summaries

Claimant: *Mandate Films, LLC* (Licensor)  
Respondent: *EEAP Eastern European Acquisition Pool GmbH* (Distributor)  
Principals at the time Final Award issued: Unknown  
Arbitrator: Mark Litwak, Esq.

The Final Award found that Respondent breached the Distribution Agreement and ordered Respondent to pay to Claimant the unpaid second installment of the minimum guarantee due to Claimant under the Agreement.

No. 13-55 – Award issued on January 10, 2014

Claimant: *Entertainment One Benelux B.V.* (Distributor)  
Respondents: *Fusion Films, Inc. and Two Out of Ten Productions, Inc.* (Licensors)  
Principals at the time Final Award issued: Unknown

The Final Award (issued after a prove-up in a default case) found that the parties' Amendment to the Distribution Agreement in the event of a non-theatrical release was enforceable and ordered Respondent to pay to Claimant the unpaid amount to be refunded under the Amendment.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the balance of the minimum guarantee due under the License Agreement, and the Agreement was terminated.

The Final Award ordered Respondent to pay to Claimant the minimum guarantees due for four Pictures under the Distribution Agreement, and further ordered the Agreement terminated for such Pictures if Respondent failed to make payments. The Award also found Claimant was due only the initial advances for three additional Pictures.

The Final Award found that Respondent breached the Distribution Agreement and ordered Respondent to pay to Claimant the balance of the minimum guarantee due under the Agreement.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the balance of the minimum guarantee due under the Distribution Agreement, and the Agreement was terminated.

The Final Award (issued after a prove-up in a default case) found that Respondent Fusion Films, Inc. breached the Distribution Agreement and ordered it to pay damages and any monies it received to Claimant pursuant to the Agreement. The Award also found that no rights were transferred from Respondent to Claimant. The Award further ordered Respondent to indemnify Claimant as to the judgments entered against Claimant pursuant to a Notice of Assignment entered into by the parties and dismissed the remaining Respondents from the arbitration.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the amount due to Claimant from Respondent's exploitation of the Pictures under the Distribution Agreement. The Award also terminated the Agreement and found that all rights reverted to Claimant. Respondent was ordered to return to Claimant all materials related to the Picture.

The Award further ordered Respondent to return all materials related to the Picture to Claimant. The Award also terminated the Agreement and found that all rights reverted to Claimant.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the balance of the minimum guarantees due under two Distribution Agreements, and the Agreements were terminated.

After arbitration was ordered by the U.S. District Court in Florida, the Final Award found that Claimant was not defamed by Respondents' documentary Picture and subsequent press release which promoted the Picture.

The Final Award (issued after a prove-up in a default case) found that the Respondents breached the Distribution Agreement (as amended) for failure to satisfy a condition of the Agreement with respect to a theatrical release for the Picture. The Award ordered Respondents to continue to perform their obligations and to deliver all materials to Claimant due under the Agreement.

No. 13-100 – Award issued on March 24, 2014

Respondent: *Duka Film* (Distributor)

Principals at the time Final Award issued: Unknown

The Final Award found that the Claimant was entitled to terminate all five License Agreements for Respondent's failure to pay the amounts due under certain Agreements. The Award did not order Respondent to pay outstanding balances; however, Claimant was permitted to retain previously paid amounts as liquidated damages. The Award further found that all rights reverted to Claimant and ordered Claimant to remit mitigated damages to Respondent after relicensing two Pictures.

The Award further found that Claimant was not entitled to recover fees for additional music editing and re-writing, nor public performance royalties in connection with the Picture.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantees due under five Distribution Agreements. The Award also terminated the Agreements and found that all rights reverted to Claimant.

The Award also terminated the Agreement and found that all rights reverted to Claimant.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee as well as participation payments due under the Distribution Agreement.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantee due under the Distribution Agreement. The Award also terminated the Agreement and found that all rights reverted to Claimant.

The Award ordered Respondents to pay to Claimant all revenue due and to provide a full accounting statements. Merchant Ivory Productions (USA), Inc. was joined as a Respondent to the arbitration.

The Final Award (issued after a prove-up in a default case) ordered Respondent to pay to Claimant the minimum guarantees due under six Distribution Agreements. The Agreements were terminated. Pursuant to cross breach termination clauses, other agreements which were not in default, were also terminated.

Comerica Bank and ProSight Specialty Management Company, Inc. were dismissed from the arbitration.
